## **We hereby agree with your Terms and Conditions for Documentary Credits:**

1. In consideration of this documentary credit to be opened by you on my/our behalf, I/we hereby undertake and agree that unless you have previously been provided with funds for this purpose, I/we will reimburse you on your demand for all payments effected by you, your branches or your correspondents in the terms thereof, together with commission and all charges. My/Our reimbursement shall be due three days before maturity in the case of acceptances or on presentation in case of sight drawings. It is understood that interest, where applicable, shall be calculated at the prevailing market rate from the date of payment by you or your correspondent until the reimbursement amount is actually at your disposal for my/our account.
2. You are not liable or responsible as to the terms, conditions or sufficiency of the insurance policies or certificates. However, in the event of insurance not being arranged to your satisfaction you are authorised at your absolute discretion, but without your being under any obligation in the matter, to effect such insurance at my/our expense.
3. I/We hereby authorise you to hold the documents called for by the terms of this credit and the merchandise to which they relate as security for all liabilities incurred by you or your correspondents or agents in connection with this credit including expenses and charges of whatever nature incurred in relation to the said merchandise or the obtaining of possession or the disposal thereof. You are herewith authorised to incur such expenses at your own discretion and we undertake to reimburse you such expenses and charges. You may sell the said merchandise either before or after arrival at your discretion and without notice to me/us. For the same purpose we hereby assign to you all rights and claims under the relative insurance policies and/or claims against third parties related to the documents in your possession, whether arising directly from such documents, from contracts related hereto or from any other legal reason.
4. Should you elect to hand over to me/us the relative shipment documents for the purpose of clearing and realising the shipment or shipments or for any other purpose, I/we engage to hold such documents or the relative merchandise or the proceeds thereof as a trustee on your behalf.

We request you to issue on our behalf and for our account your Irrevocable Credit in accordance with the above instructions (marked (x) where appropriate).

This Credit will be subject to the Uniform Customs and Practice for Documentary Credits (1993 Revision, Publication No. 500 of the International Chamber of Commerce, Paris, France), and to the General Business Conditions of your Bank, available at your counters and to your terms and conditions for documentary credits as printed above.
